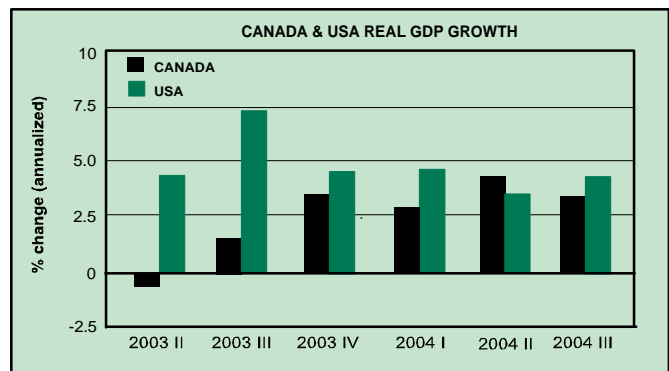
### Introduction

Despite all the shocks to the Canadian economy in 2003 - mad cow disease, SARS, a blackout in Ontario, forest fires in Western Canada, a hurricane in Atlantic Canada - Canada's real Gross Domestic Product (GDP) grew by 2 percent. In 2004, economic performance has been solid in Canada as strong global demand and supply concerns have kept commodity prices high. Provinces reliant on natural resources, such as Saskatchewan, should post solid economic growth based on increased activity in their oil, gas and mining sectors. Strong economic growth in the United States has been good for the export-oriented manufacturing sectors of central Canada. Overall, private forecasters expect, on average, Canada's real GDP to post a 3.0 percent increase in 2004.

In Saskatchewan, a remarkable increase in agricultural output helped the provincial economy outperform the national average in 2003 for the first time since 1996. Saskatchewan's 4.5 percent increase in real Gross Domestic Product (GDP) was the second-highest rate among the ten provinces. Healthy activity in the province's oil and gas fields, as well as other mining, will fuel further economic growth in 2004. However, increases in this year's crop production will fail to match last year's increase, leading to a smaller, but still respectable, rate of economic growth in 2004.

The first nine months of 2004 saw continued economic growth in the US economy. The economic recovery that began in 2002 and built momentum in 2003 continued to post solid gains throughout 2004. Preliminary estimates indicate that US real GDP grew at an annualized rate of 3.9 percent in the third quarter, following gains of 4.5 percent and 3.3 percent in the previous two quarters.

A strong economy south of the border is beneficial to Canadian exporters, and the Canadian economy has posted solid gains in quarterly economic growth throughout 2004. On the back of strong demand for exports, the Canadian economy grew at annualized rates of 2.7 percent and 3.9 percent in the first two quarters of 2004. Third quarter economic growth in Canada was a solid 3.2 percent.



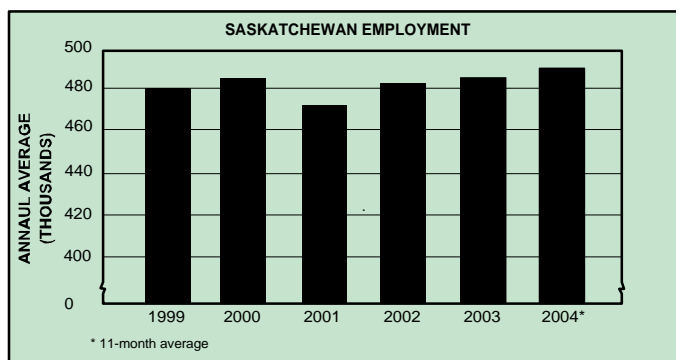
However, with the surge in US economic growth beginning to abate, the boom to Canada's exports is subsiding. Third quarter estimates show that exports fell by 2.0 percent in the third quarter of 2004 after three consecutive quarters of growth. In addition, the relatively high value of the Canadian dollar is further dampening exports. At the same time, Canadian imports are increasing. Combined, weaker international demand and the high Canadian exchange rate pose a significant impediment to Canada's economic growth in the second half of 2004.

In Saskatchewan, economic growth will be positive in 2004, but it will be at a slower rate of expansion than last year. A large part of the 2003 rebound in economic growth was a result of the 46 percent rise in crop production. This will not be repeated in 2004.

Rather, Saskatchewan will ride rising demand and high prices for its energy and mineral resources to another year of positive economic growth. International exports were strong in the first half of 2004 and, domestically, the manufacturing, housing and retail sectors remained buoyant. Private forecasters, on average, are calling for 3.1 percent growth in Saskatchewan real GDP in 2004, while employment is expected to grow by a more modest 0.6 percent.

## Employment

Employment in Saskatchewan continues to grow, albeit at a slow pace. After posting a one percent increase in 2003, employment expansion has slowed over the first eleven months of 2004. Through November 2004, employment averaged 490,300. This is an increase of 3,200 jobs (0.6 percent) over the same period in 2003. Despite the modest growth in the job market, 2004 employment levels will be the highest on record if the trend continues.



Employment growth has been concentrated in the goods-producing sector in 2004, in contrast to 2003 when the sector posted losses. Overall, average employment in goods-producing industries grew by 6,700 jobs, or 5.5 percent, through the first eleven months of the year. The

sizzling energy sector led to an additional 2,200 jobs in the mining, oil and gas sectors, a 13.5 percent increase. Manufacturing has added another 1,600 jobs, up 5.7 percent.

The agricultural industry continues to struggle and this is reflected in the industry's employment levels. Growth in average employment has been stagnant in 2004, expanding by 500 jobs. Strong housing starts helped the construction industry add 1,400 jobs, while the utilities sector added another 1,000.

The majority of jobs in the goods-producing sector are full-time, so employment growth here is a positive development. Indeed, 2004 employment growth was concentrated in the full-time category, expanding by 1.3 percent over the first eleven months of the year. Conversely, part-time employment decreased 2.1 percent.

Employment in service-producing industries decreased 1.0 percent over the first eleven months of 2004, led by a 10.6 percent decline in public administration and a 5.0 decrease in finance and insurance.

Saskatchewan continues to have one of the lowest unemployment rates in the country. Between January and November, unemployment averaged 5.4 percent, down from the 2003 eleven-month average of 5.7 percent. Canada's unemployment over the same time period in 2004 averaged 7.3 percent. Saskatchewan's youth unemployment rate continues to be one of the lowest in the country.

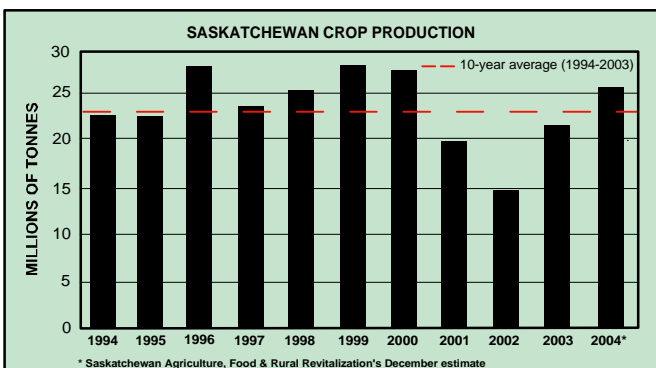
Finally, between January and November, the employment-to-population ratio averaged 64.7 percent, higher than the record 64.4 percent experienced in 2003.

## Agriculture

After two consecutive years of drought in 2001 and 2002, growing conditions improved in 2003 leading to a 46 percent increase in crop production. The 2004 growing season began with high expectations. Good moisture conditions were reported through much of the province, and farmers were optimistic that 2004 would be another good year.

However, a cool, wet summer stunted crop development and an early frost dashed expectations of a bumper crop. By early October, only 51 percent of the harvest was complete, compared to the five-year average of 86 percent for that time of year. Game and migrating waterfowl began to take their toll on crops still standing as the harvest dragged further into the fall.

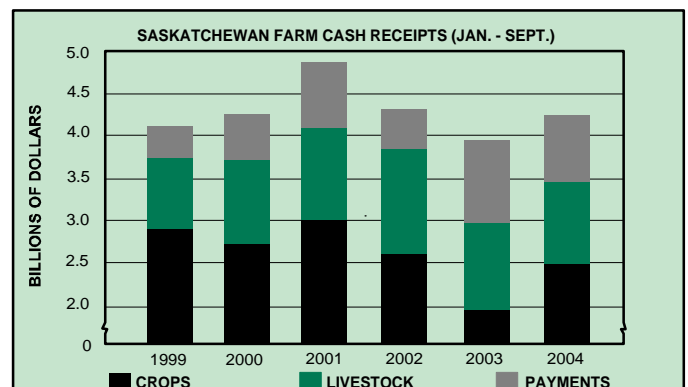
The poor growing conditions and later-than-usual harvest resulted in a downward revision to anticipated yields and quality. Saskatchewan's harvest is now estimated to be 25.5 million tonnes, 17 percent higher than the 2003 harvest. While the 2004 harvest is also higher than the 10-year average, it is short of earlier expectations. Yields are expected to be above average throughout the province for all of the major grains, oilseeds and specialty crops, with the exception of flax and canary seed.



While the quantity of crops harvested is encouraging, it is clear that the quality will be well below average due to the challenging conditions experienced in 2004.

Saskatchewan Agriculture, Food and Rural Revitalization expects that only 6 percent of spring wheat and durum will be graded No. 1 Canada Western (CW), compared to the 10-year average of 59 percent and 42 percent, respectively. Similar quality observations hold across all crops.

Farm cash receipts for the first three quarters of 2004 rose 7.8 percent from the same period one year ago, in large part due to increased crop receipts. Receipts from wheat, barley, oats and canola deliveries were all higher. Total crop receipts increased 28.5 percent over the same period last year. However, the poor 2004 growing season began to take its toll in the third quarter of 2004 as total crops receipts for this period were 5 percent lower than the same period in 2003. The delay in the 2004 harvest, which seriously downgraded the quality of crops, will likely continue to be reflected in crop revenues for the next several quarters.



The cattle industry in Saskatchewan continues to struggle in the aftermath of the discovery in 2003 of a single case of mad-cow disease in the Alberta herd. Cattle marketings plummeted in 2003, decreasing 12 percent. The US border remained closed to live Canadian cattle in 2004.

In response, the domestic slaughtering industry increased its demand for cattle as the US began to allow certain cuts of beef into their market. Exports of cattle to Alberta rose 211 percent over the first nine months of

2004. Total marketings of slaughter cattle reached 277,190 cattle, a 33 percent increase year-to-date, despite not a single live export to the United States.

However, the feeder cattle market dragged down total marketings in 2004. Over the first nine months of 2004, marketings of feeder cattle decreased 7 percent, including a 17 percent drop to Saskatchewan farms and feeder lots. Despite this, through September, total cattle marketings increased 1.5 percent over the same period in 2003 to reach nearly 984,000 cattle.

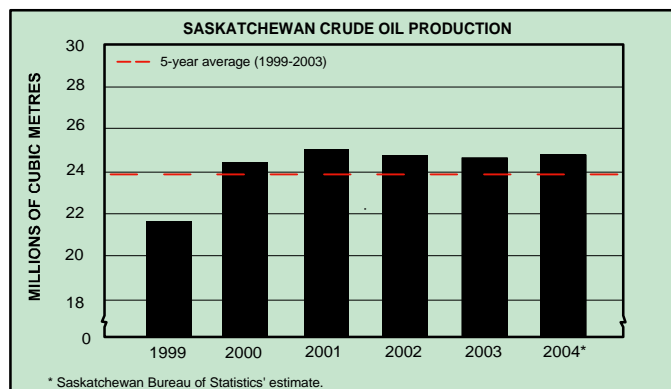
Cash receipts from livestock sales grew at a mere 1.1 percent over the period, a much slower pace than crop receipts. Substantially lower prices for both slaughter and feeder cattle resulted in receipts from the sale of calves falling 22 percent, while cattle receipts fell 1.5 percent. Hog producers experienced higher sales receipts and were responsible for the overall increase in total livestock receipts, earning \$83 million over the time period. This was an increase of 20 percent over the same period in 2003.

## Mining, Oil and Gas

Soaring energy prices have allowed the Saskatchewan energy sector to continue its expansion. Production in the province's oil and gas fields are at elevated levels and production of other minerals, such as potash and uranium, continues to grow due to strong global demand. Solid growth in this sector should lead the Saskatchewan economy to another year of respectable economic growth in 2004.

Crude oil production has remained relatively flat throughout 2004, but the value of output has increased significantly thanks to high oil prices. Through the first eight months of the year, crude oil production was up 1.1 percent to 16.2 million cubic metres. While production

was relatively flat, the total value of Saskatchewan oil sales were up 9.4 percent thanks to the steady rise in crude oil prices. The average monthly price of a barrel of West Texas Intermediate (WTI) crude broke through the US\$40 mark in the summer and has remained high. As of September, crude oil prices had shown a 26.2 percent increase over 2003 prices, averaging US\$39.11 a barrel.



Demand for natural gas has also increased in 2004 and Saskatchewan producers have responded. Natural gas production was up 4.0 percent through the first eight months of the year.

Production in Saskatchewan's mines remains strong. Potash production is on pace to surpass the record levels set in 2003. Through September, potash production totaled 7.1 million tonnes, up 12.8 percent from the same time period in 2003. The value of potash sales increased 26.6 percent and year-to-date uranium production was up 11.4 percent as of September.

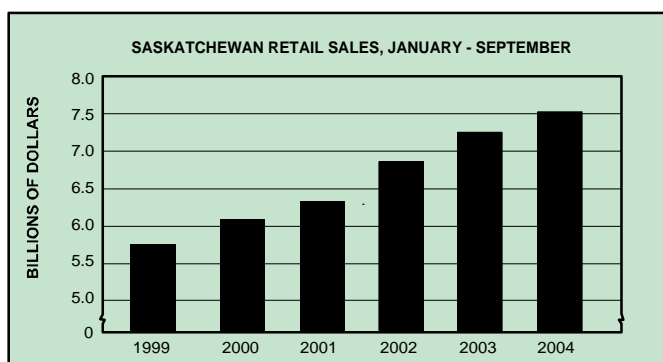
## Economic Expansion

All indications are for another year of positive economic growth in 2004 in Saskatchewan after real GDP growth of 4.5 percent last year. Despite a disappointing harvest, several other key economic indicators point to continued expansion of the Saskatchewan economy. On the external side, exports continue to rise, while at home, consumers continue to drive the provincial economy.



Despite the recent rise of the Canadian dollar and the continued closure of the US border to live Canadian cattle, exports originating from Saskatchewan have been strong in 2004. Total value of international exports for the province were 20.8 percent higher than in 2003 in the January to September period, including a 22.1 percent gain in agricultural products.

Within the province, employment gains and increases in personal income have combined to encourage consumers to continue spending. Through September, retail sales were up 3.6 percent year to date, while housing starts were up 4.4 percent. The increase in housing starts was driven by a 47.9 percent surge in starts in the Regina housing market.



Manufacturers in Saskatchewan continue to experience good business conditions. After rising 3.7 percent in 2003, the value of shipments from Saskatchewan manufacturers were up 22.7 percent year-to-date as of September. Gains were seen across the entire sector, including a 63 percent increase in wood products, a 24 percent increase in chemical products, and a 17 percent increase in fabricated metals.

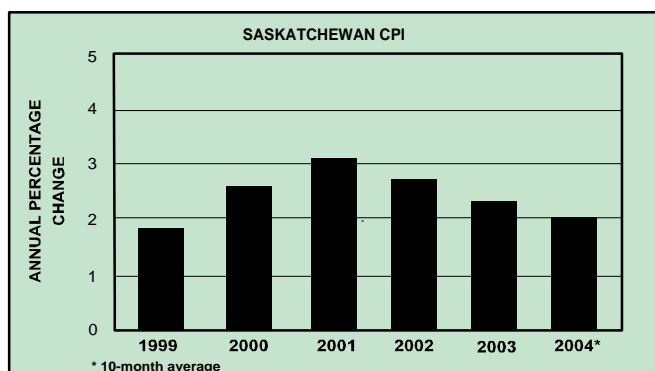
However, not all sectors of the provincial economy are experiencing growth. Investment, a large component of economic growth, is set to decline in 2004 and dampen the economic expansion. Notably, preliminary investment intentions of both the public and private sectors forecast a decline in new investment spending in 2004.

The most recent data shows that planned spending on new capital and machinery in 2004 will fall by 4.4 percent. Indeed, few non-residential investment projects have been undertaken in 2004, as evidenced by the fall in non-residential building permits. As of September, the year-to-date value of non-residential building permits was down 14.6 percent from 2003 levels. Softness in the investment sector poses a risk to economic growth over the second half of the year.

## Consumer Price Index

Based on ten months of data, the average increase in the Saskatchewan All-Items Consumer Price Index (CPI) was 2.0 percent. Increasing energy costs pushed the transportation and shelter indices up 2.5 and 2.6 percent, respectively. The price of food was up 2.1 percent and the cost of alcohol and tobacco rose 5.4 percent.

The All-Items Consumer Price Index for Regina rose 2.0, while the Saskatoon All-Items CPI increased 1.9 over the first ten months of 2004. The national average CPI increased 1.7 percent over the same period.



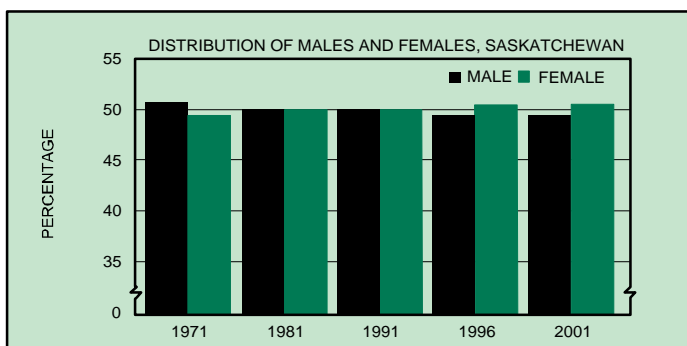

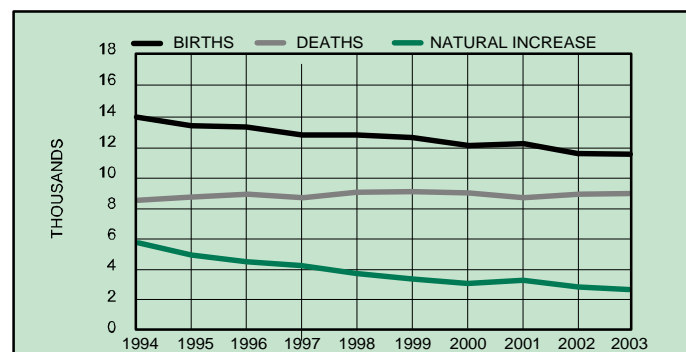

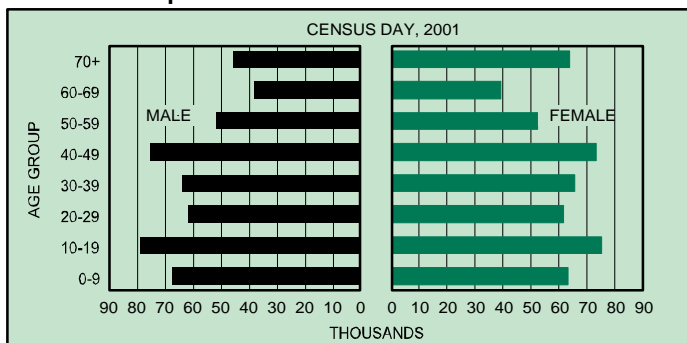

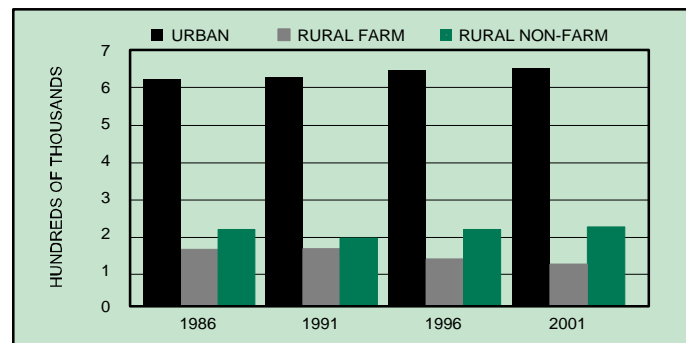

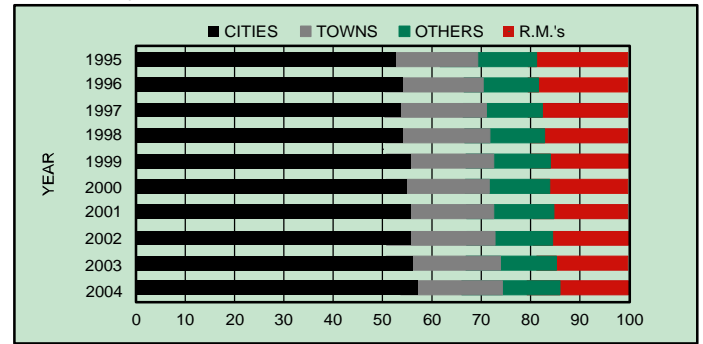

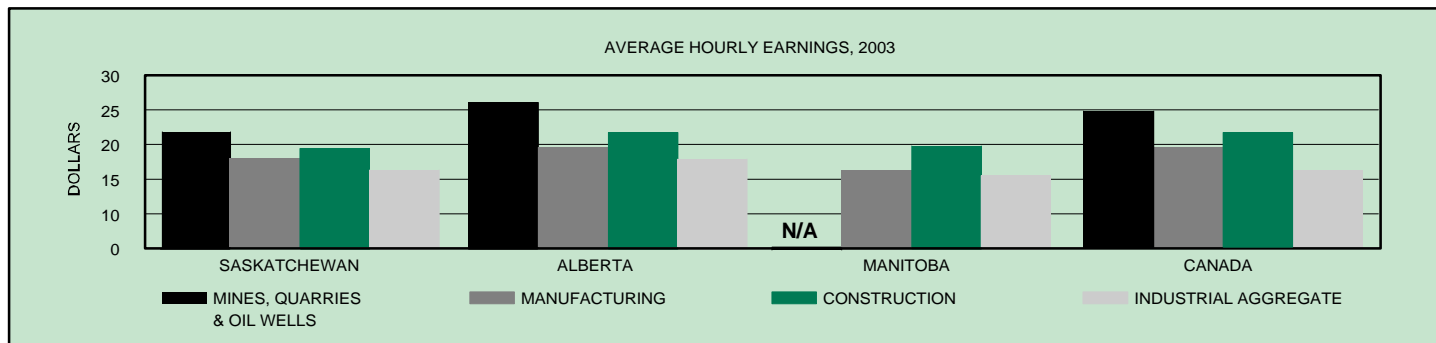

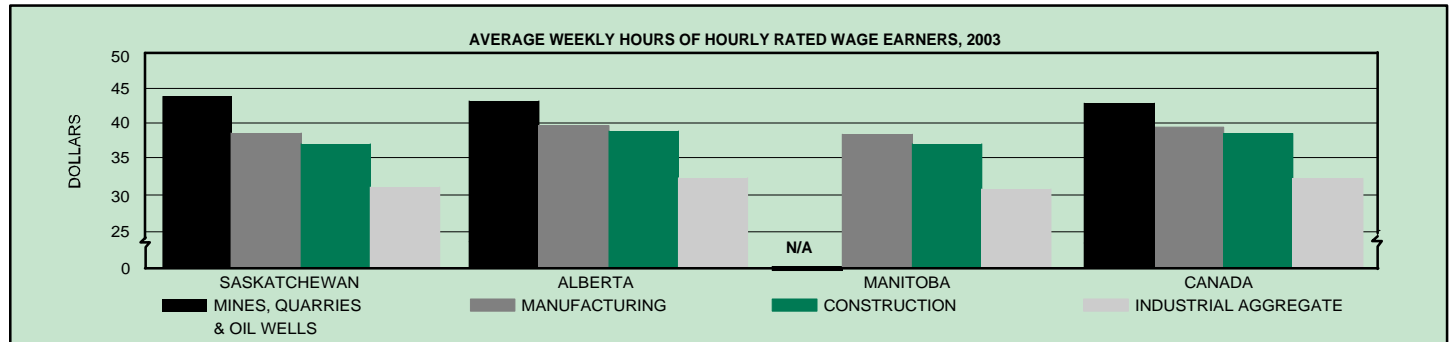

**Table 19: Indexes of Farm Costs (1992=100)**



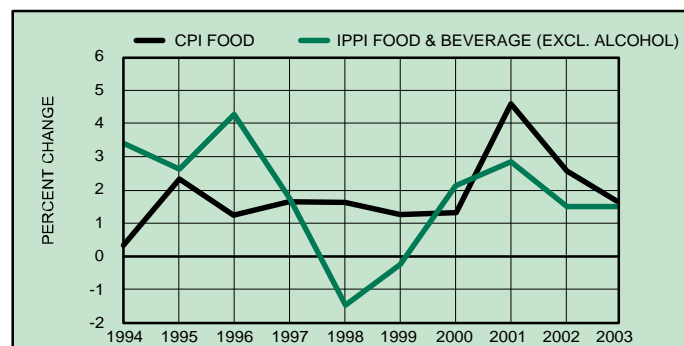

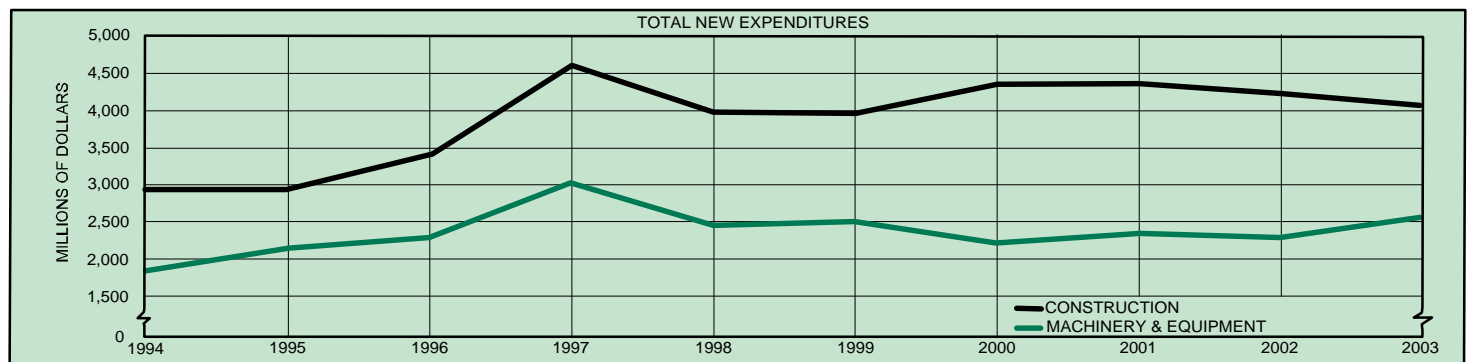

Table 21: Private and Public Investment by Industry, Saskatchewan



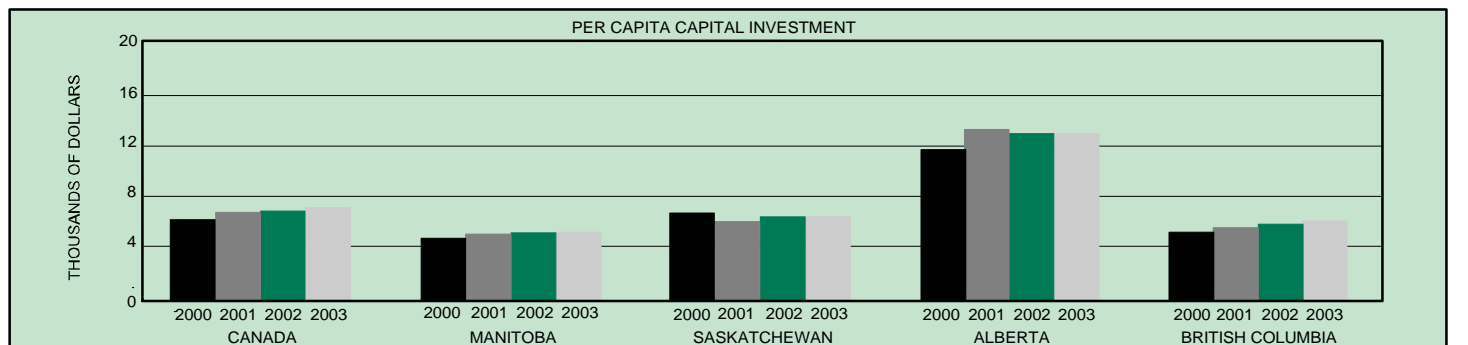

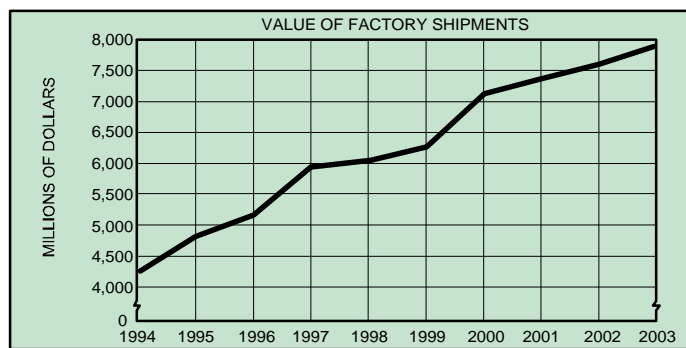

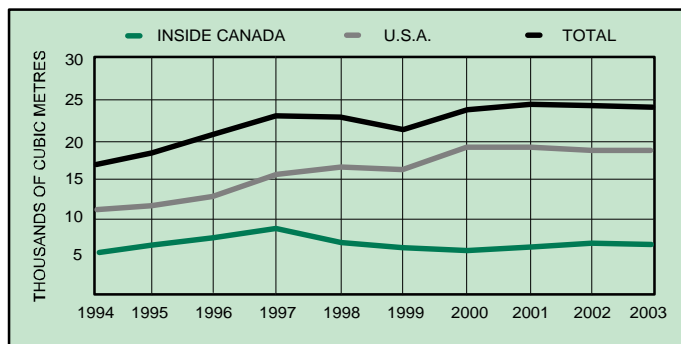

Table 29: Principal Markets for Saskatchewan Crude Oil



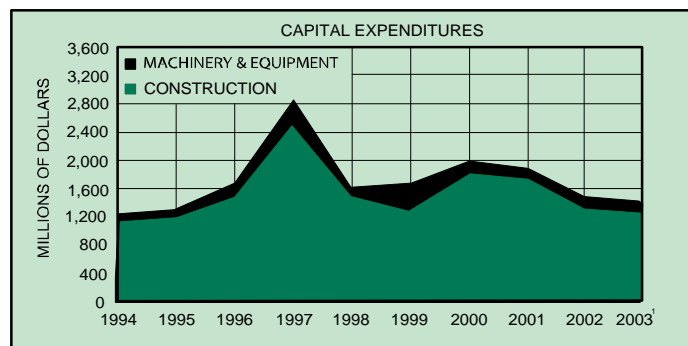

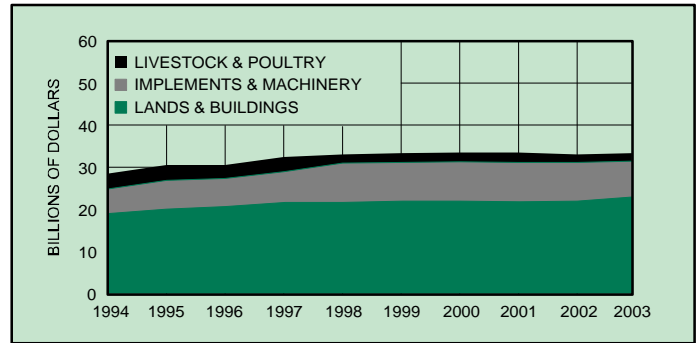

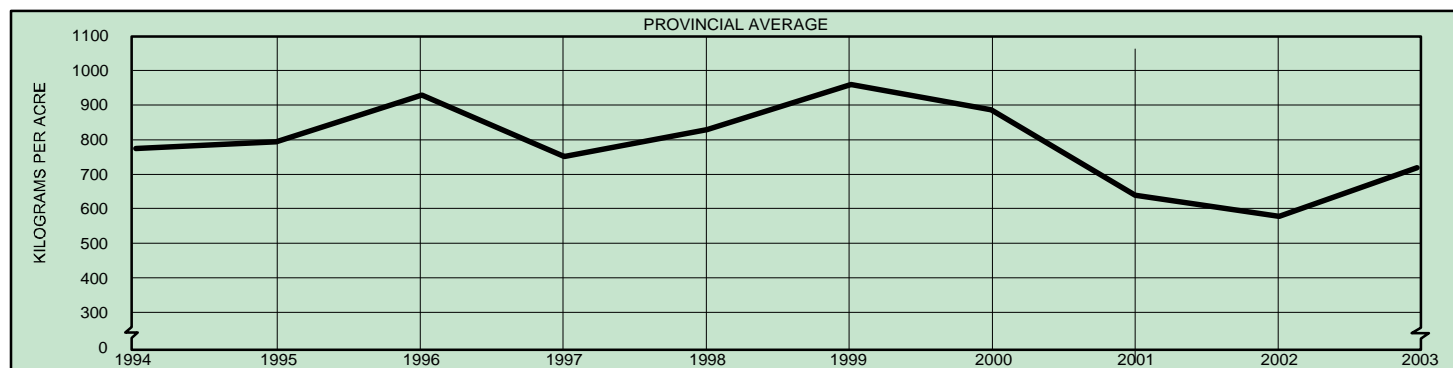

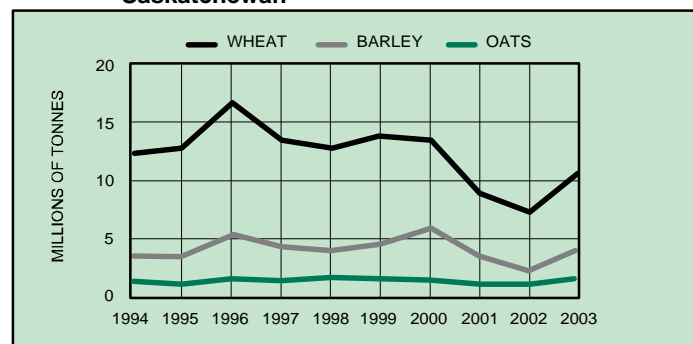

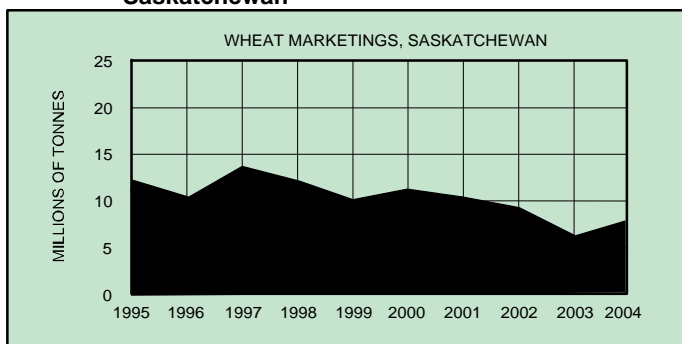

**Table 43: Outstanding Farm Debt as of December 31, Saskatchewan**

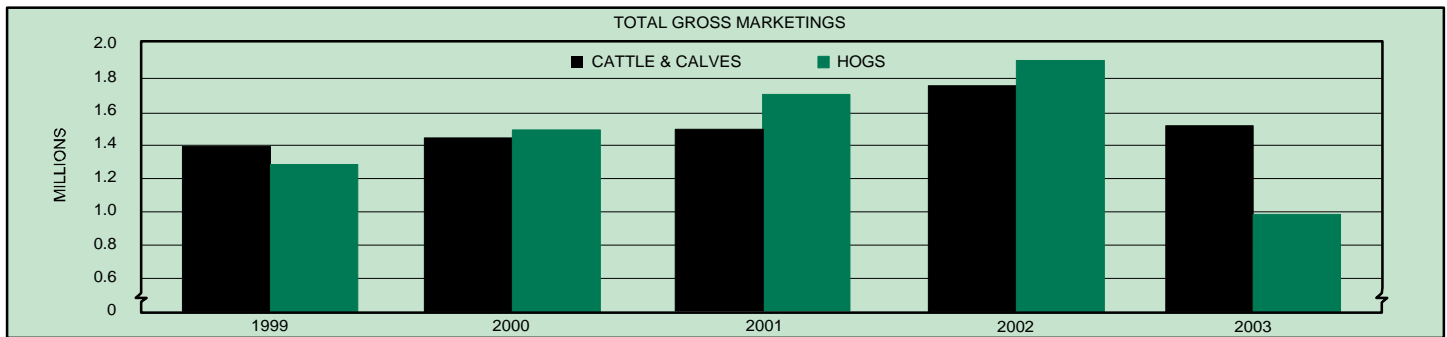

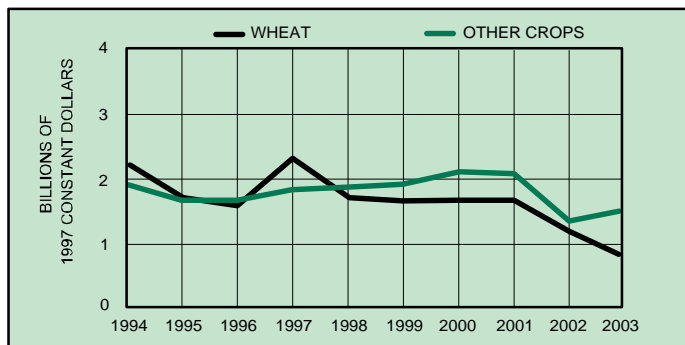

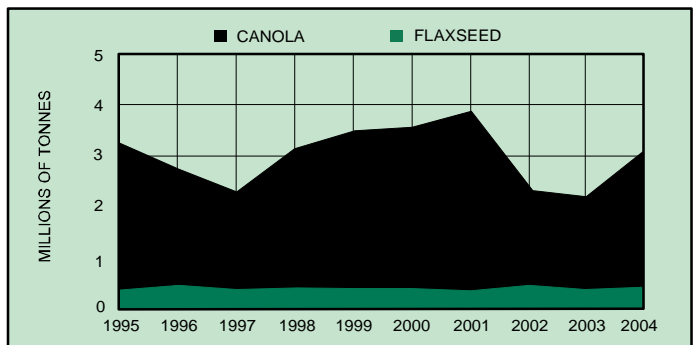

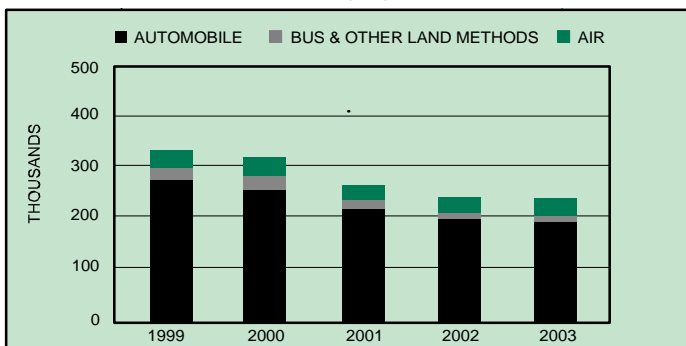

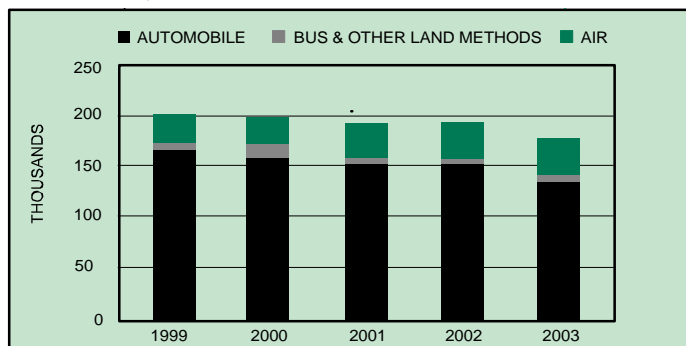

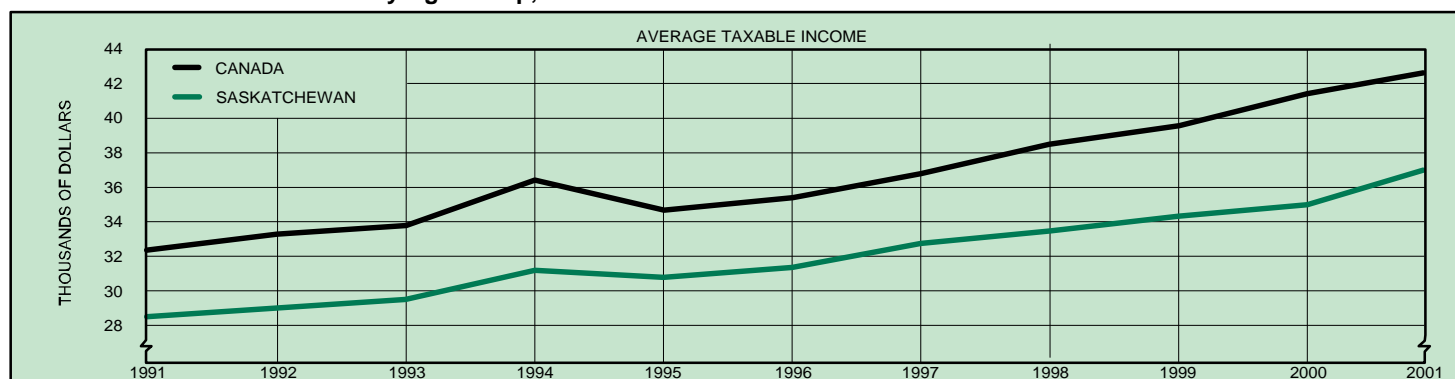

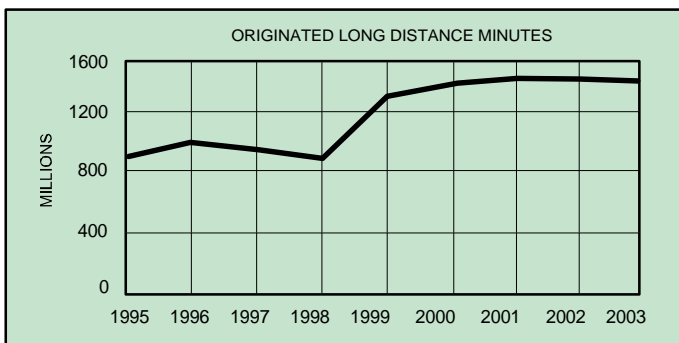

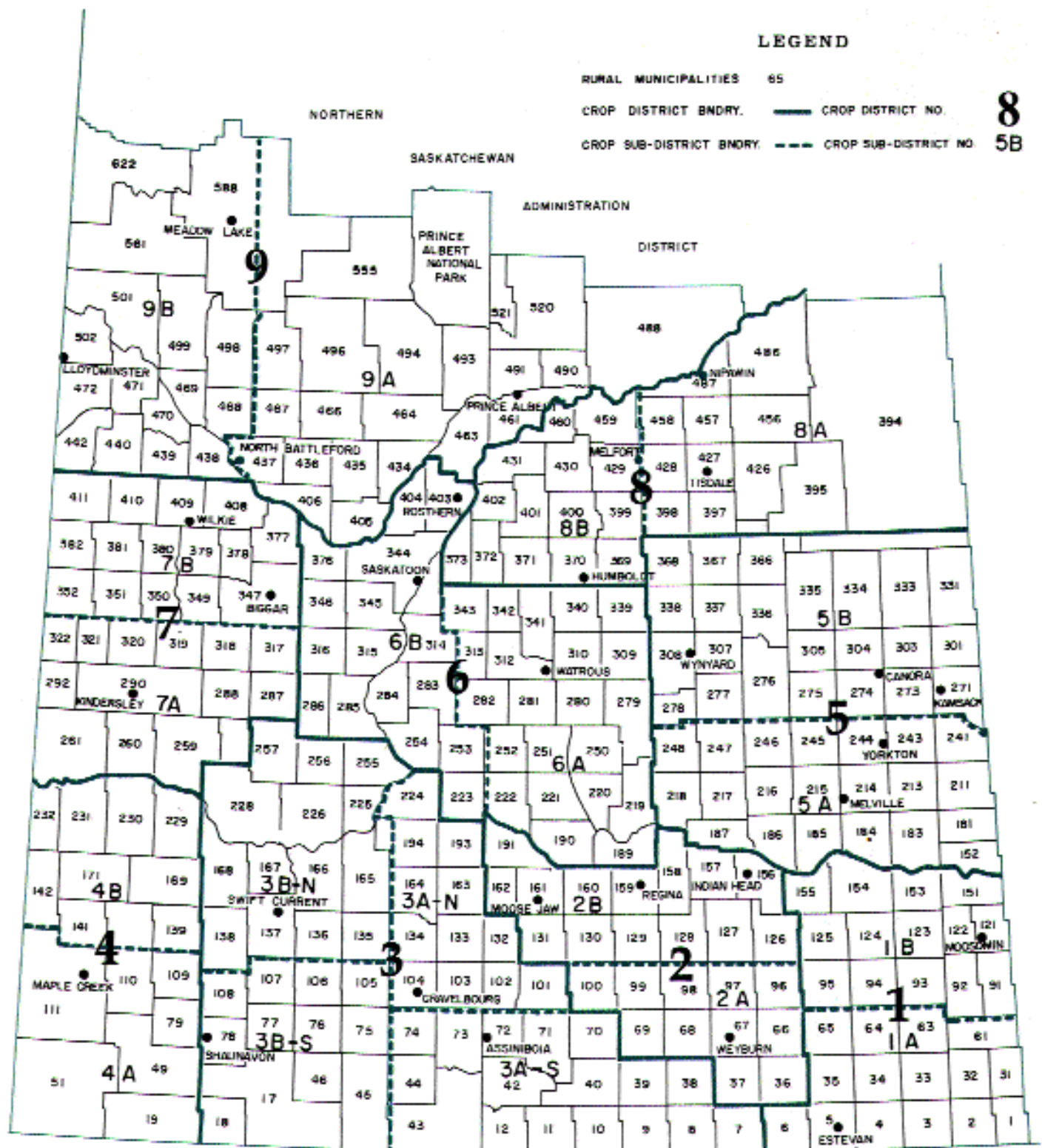

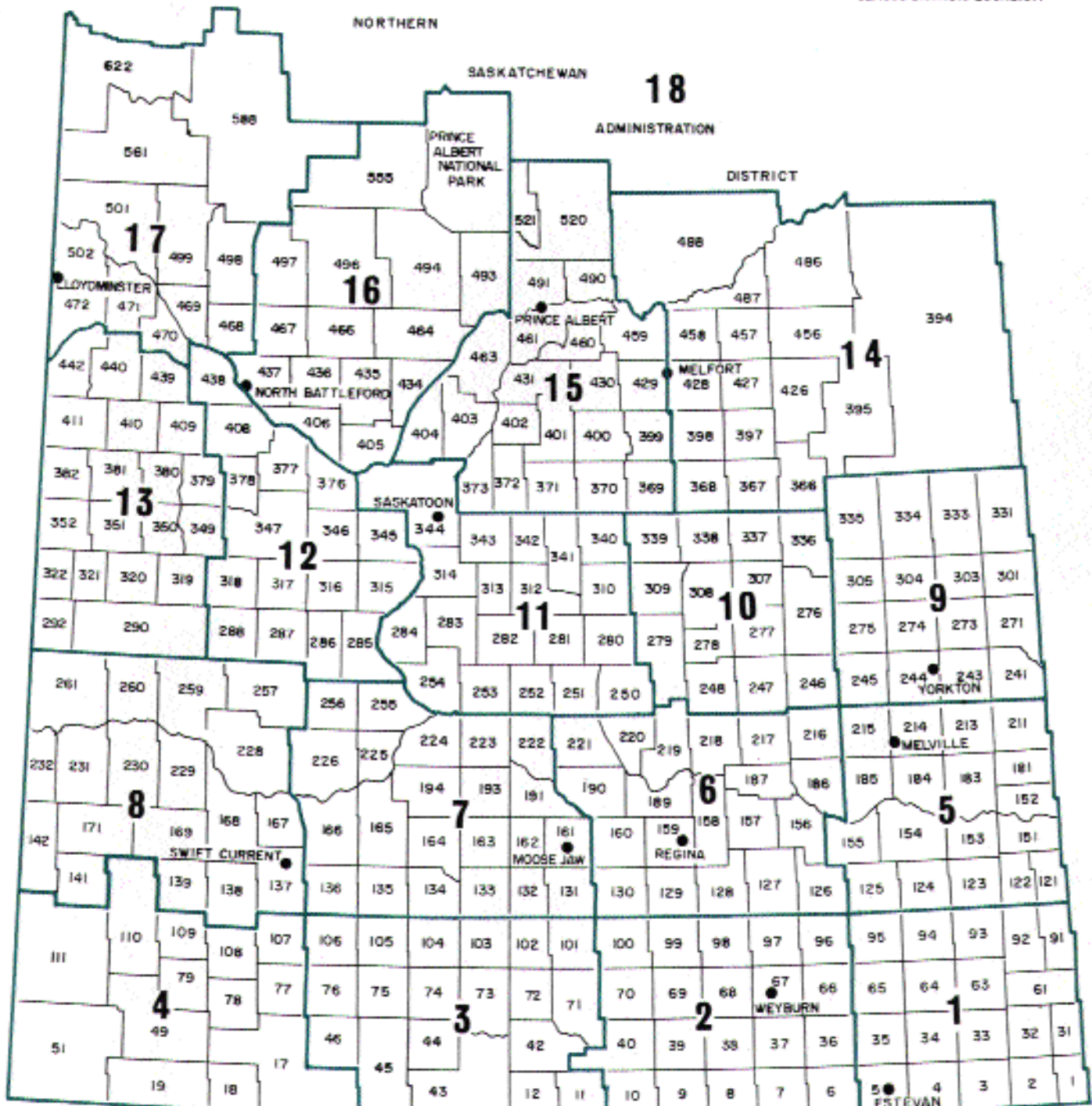

# Saskatchewan Economic Accounts

---

The Saskatchewan Bureau of Statistics has developed a set of economic accounts which can be used to trace the development and growth of the Saskatchewan economy.

The purpose of the accounts is to measure the value of economic activity in each sector of the economy. This is done by means of a balancing set of accounts similar to the annual income and expenditure statements of a commercial enterprise.

The accounts have many useful functions. They consolidate information which is now provided through a number of scattered sources and organize it into a central framework. This allows many kinds of economic analysis to be performed ranging from monitoring current economic performance to analysis of structural change in the economy.

The Saskatchewan Bureau of Statistics has adopted the Chain Fisher volume index methodology for calculating real Gross Domestic Product (GDP). This method of calculating real growth in the economy removes potential substitution bias that exists when using a constant-dollar method (the Laspeyres index).

The Saskatchewan Bureau of Statistics has available, upon request, many more detailed tables and other information concerning the Saskatchewan Economic Accounts.

## Saskatchewan Economic Accounts

Saskatchewan Gross Domestic Product (GDP) measures the total value of goods and services produced annually in the province. By removing the effects of inflation, it is possible to measure the volume of output. After adjusting for price changes, Saskatchewan's real Gross Domestic Product increased by 4.5 percent in 2003 (chained 1997 prices).

In nominal terms, Saskatchewan's GDP increased by 6.1 percent in 2003 to \$36,519 million. Personal expenditure on consumer goods and services rose by 4.4 percent. Spending rose by 3.7 percent on durable goods, 5.1 percent on non-durable goods and 4.7 percent on services. Government current expenditure on goods and services rose by 6.1 percent in 2003. Total investment increased by 1.7 percent in 2003.

In 2003, nominal exports increased 0.8 percent from 2002 levels. Nominal imports increased by 3.1 percent in 2003. In real terms, exports increased by 1.8 percent while imports increased by 4.8 percent in 2003.

Personal income in Saskatchewan rose by 3.2 percent in 2003. Wages, salaries and supplementary incomes (on a Gross National Product basis) rose 4.9 percent and net income of non-farm unincorporated businesses increased

by 5.3 percent, but net income received by farm operators declined by 80 percent. After subtracting direct taxes, contributions to social insurance plans, and pension plan contributions, personal disposable income rose by 3.8 percent. However, personal savings remained negative in 2003 (-\$1 billion), the largest deficit on record.

Real personal expenditure on consumer goods and services increased by 2.4 percent, government expenditures on goods and services increased by 3.5 percent and real gross fixed capital formation increased by 2.6 percent. Final domestic demand for goods and services by individuals, the government and for investment purposes increased by 2.7 percent in 2003.

This document represents an update to the Saskatchewan economic accounts, released in May 2004. Periodic revisions are common to all economic series, as more comprehensive data is obtained, in order to improve the accuracy, reliability and consistency of the data.
