Introduction

More of the same seemed to be the catchphrase for the provincial economy in 2005. Many of the opportunities and problems present in 2005 were already there in 2004. Saskatchewan continued to benefit from global economic strength and exceptionally high non-agricultural commodity prices, but faced the same challenges in agriculture.

The potential impact of spiraling energy prices on global economic growth was a concern last year. However, the economies of the United States, China and other countries the province trades with remained vibrant and their economic vitality likely contributed to the rise in commodity prices. At the same time, the value of the Canadian dollar continued to increase, partly due to the spike in commodity prices, partially offsetting the benefits of the latter.

In 2005, a visible level of economic performance was recognizable across the province. As international exports soared, a rising level of consumer spending combined with escalating non-residential construction activity to expand the economy. According to private sector forecasters, Saskatchewan's real Gross Domestic Product (GDP) grew by 3.3 per cent, the third highest growth posted by any province.

Economic Expansion

A quick glance of Saskatchewan's 2005 economic performance indicates a year full of successes. These include a 13.8 per cent increase in international exports,

third highest growth posted by any province; retail sales growth of 7.6 per cent, second highest growth posted by any province; 14.3 per cent increase in wholesale trade, third highest across Canada; and, an 8.2 per cent increase in manufacturing shipments, second highest in the country.

New dwelling starts in 2005 compared to 2004 were down both in Regina (28.5 per cent) and Saskatoon (32.7 per cent) as well as Saskatchewan (9.1 per cent). It is important to recognize, however, that 2004 was already an outstanding year for home construction in the province (14.0 per cent increase) and it can be difficult to repeat this kind of performance each year.

The real strength of the provincial construction industry is reflected in the value of building permits issued last year. Despite the cooling in residential construction, there was still a 17.6 per cent increase in the total value of building permits in 2005, the third highest growth posted by any province. Industrial building permits rose 78.4 per cent, commercial building permits increased by 28.7 per cent and institutional/government building permits grew 38.6 per cent.

Actual levels of investment in 2004 exceeded those of 2003 by 3.1 per cent. When including spending on the repair of equipment and machinery, actual investment expenditures in 2004 increased by 5.0 per cent over 2003. Preliminary actual statements of investments in 2005 have new investments up by 4.6 per cent over 2004.

Employment

Employment in Saskatchewan increased in 2005. Through December 2005, employment averaged 483,500. This is an increase of 3,800 jobs (0.8 per cent) over 2004. Despite this modest growth, the employment level last year was the highest on record.

Employment growth has been measured in many sectors in 2005, a pattern broadly similar to 2004. However, the specific gains were somewhat different in each year. Overall, average employment in manufacturing grew by 1,500 jobs in 2005 while employment in construction went up by 2,300 jobs. There were increases in these sectors in 2004, but there were only 700 new positions in construction that year. A surge in construction activity boosted employment in the construction industry in 2005.

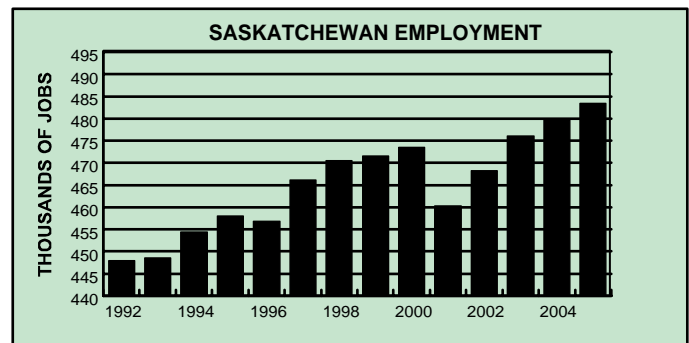
Transportation and warehousing, which grew in 2004, also expanded in 2005 by 1,900 jobs. Employment in wholesale and retail trade declined by 800 positions in 2004 but expanded by 1,500 in 2005. An increase of 1,400 jobs in public administration compensated for the decline of about 500 positions in that sector in 2004. However, losses in financial services of 1,000 jobs continued the trend seen in 2004. Fortunately, the year-to-year decline was less than the 1,400 seen in 2004. Perhaps the largest loss in 2005 was that of 3,400 jobs in the accommodation and food sector.

Agriculture continued to struggle and this was reflected in its employment levels. Agriculture employment has been flat, increasing by only 100 jobs in 2004 and declining by 100 in 2005.

As in 2004, overall employment growth was concentrated in the full-time category. Full-time employment expanded by 3,600 jobs in 2005 or 0.9 per cent over the year. Part-time employment increased by 200 jobs.

At the end of 2005, Saskatchewan had the third lowest unemployment rate in the country. Saskatchewan's unemployment rate averaged 5.1 per cent for the year, down from the 2004 average of 5.4 per cent. Canada's unemployment over the same period averaged 6.8 per cent, down from 7.1 per cent in 2004. Saskatchewan's average youth unemployment rate in 2005 improved from 10.5 per cent in 2004 to 10.1 per cent, the third lowest in Canada and tied with British Columbia.

Finally, for 2005, the employment-to-population ratio averaged 64.6 per cent, higher than the record 64.3 per cent experienced in 2004.



Consumer Price Index

The average monthly increase in Saskatchewan's All-Items Consumer Price Index (CPI) was 2.3 per cent in 2005. In Canada, the inflation rate as measured by the rate of increase in the All-Items CPI was 2.2 per cent. Provincially, increasing energy costs pushed the transportation and shelter indices up 4.6 and 3.5 per cent, respectively. The price of food was up only 0.6 per cent and the cost of alcohol and tobacco rose 2.0 per cent. The largest rise was in transportation while the smallest was in household operations and furnishings where prices rose by only 0.5 per cent. The All-Items Consumer Price Index for Regina rose 2.1 per cent while the Saskatoon All-Items CPI increased by 2.3 percent last year.

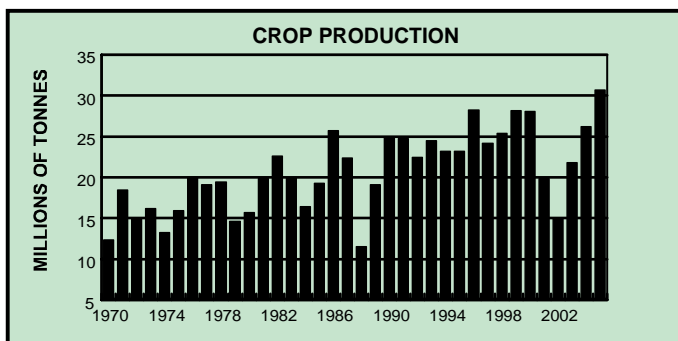
Agriculture

Perhaps one of the most dramatic events related to agriculture in 2005 was the reopening of the US border in July to bison and cattle under 30 month of age. Livestock producers responded to the partial return of American demand. Exports of feeder cattle were 19.8 percent higher than in 2004, while the total number marketed was 17.5 per cent higher. The sales of slaughter cattle increased by 9.3 per cent compared to 2004, and the total number of cattle marketed in 2005 was 15.7 per cent higher than in the previous year.

The increased demand for cattle was reflected in higher prices. December 2005 prices for D1 and D2 cows intended for slaughter were 70.9 per cent higher than in December 2004. The average price for liveweight A Steers was 12.8 per cent higher and for A Heifers, 14.8 per cent higher. The increases for feeder cattle reflected the price for steers and heifers. Depending on weight, the December 2005 prices were between 16.7 per cent and 19.7 per cent higher than in 2004.

Another positive development was the record production

of many field crops. It is estimated that 30.6 million tonnes of grain crops were harvested in 2005, the biggest harvest ever. For example, the number of bushels per acre of wheat yielded in each of the nine crop districts exceeded the 10-year average. Overall, the harvest was 28 per cent above the 10-year average and 17 per cent higher than the 2004 output.



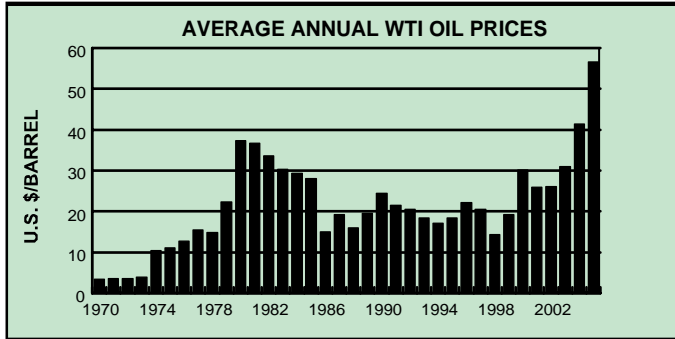
Apart from oilseeds, however, the overall quality of the grain crop harvested last year was below average. Saskatchewan Agriculture, Food and Rural Revitalization estimates that only 18 per cent of spring wheat and 26 per cent of durum graded No. 1 Canada Western (CW) in 2005, compared to the 10-year averages of 53 per cent and 38 per cent, respectively.

Specialty crops fared better. For example, 65 per cent of lentils were judged as being in the top two grades compared to the 10-year average of 74 per cent. Peas and mustard were similar, but only 39 per cent of chickpeas were in the highest grade in 2005.

Farm cash receipts for 2005 rose 3.6 per cent from 2004 in part due to increased income from sales of cattle and calves. Total receipts from crop deliveries were lower by 5.4 per cent over the same period. It is likely that the poor 2004 growing season continued to take its toll on crop receipts in 2005. The delay in the 2004 harvest, which seriously downgraded the quality of crops, remained an issue as did lower crop prices.

Mining, Oil and Gas

The spot price per barrel of West Texas Intermediate oil available for purchase at Cushing (Oklahoma) rose from an average price of US \$41.47 in 2004 to US \$56.56 in 2005. The average price per gigajoule (GJ) of natural gas also rose in the same period from \$6.07 in 2004 to \$7.93 in 2005. This one-year 36.4 per cent increase in the price of oil, paralleled by a 30.6 per cent increase for natural gas, is a key element in the current prosperity in Saskatchewan and the other fossil fuel-producing jurisdictions in Canada.



The value of sales of Saskatchewan crude oil through November 2005 was 16.1 per cent higher than in the same period in 2004. This shows the economic impact of this resource all the more because crude oil production actually had declined by 1.2 per cent in the same period due to the excessive moisture received around the Lloydminster and Kindersley areas. However, the number of new oil wells drilled through December 2005 increased by 15.3 per cent.

The value of natural gas sales through November 2005 exceeded those for 2004 by 25.7 per cent. The number of new natural gas wells drilled, however, declined by 8.1 per cent, but natural gas production through October 2005 was up 1.2 per cent when compared with 2004.

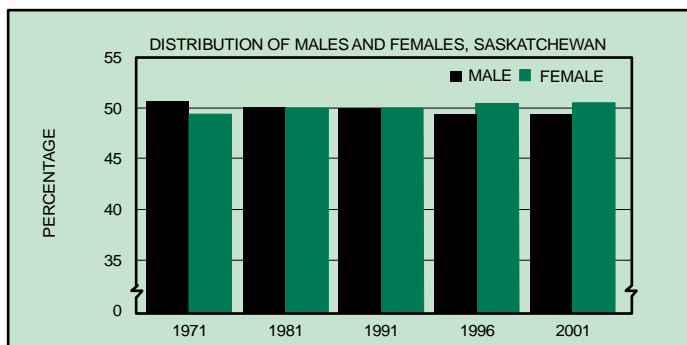
Potash production set another record in 2005 as production for the entire year totaled just over 10.1 million tonnes, up 5.1 per cent from 2004. The value of potash sales increased 24.5 per cent over the same period.

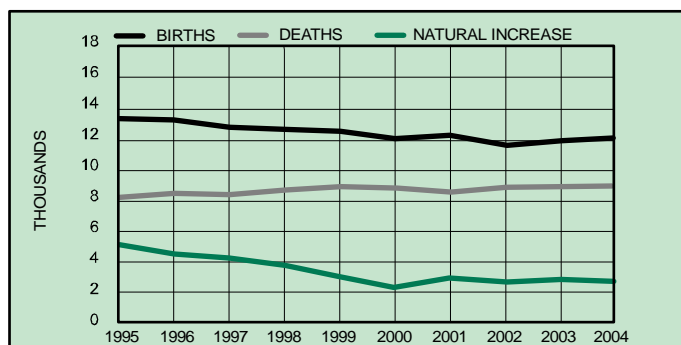
Table 1: Population, Canada and Saskatchewan by Sex

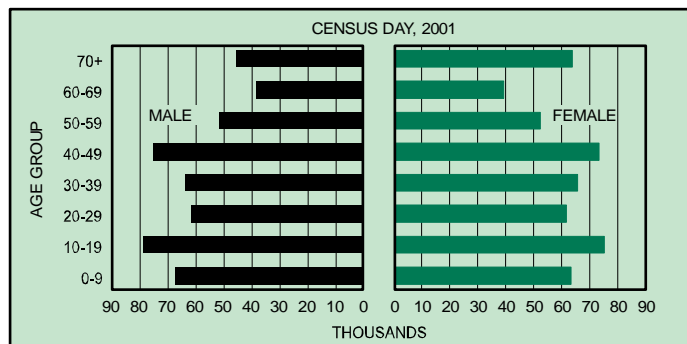
Table 2: Saskatchewan Components of Population Change

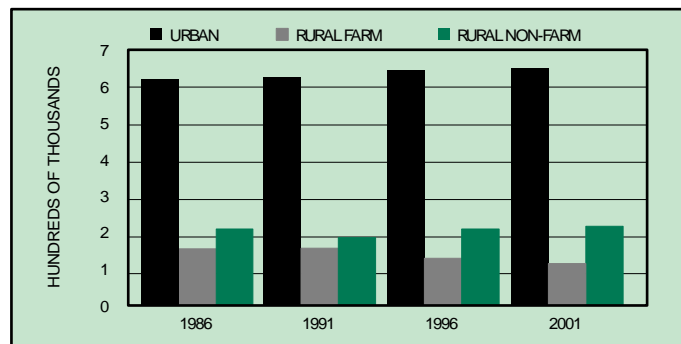
Table 3: Population, Saskatchewan Distribution by Age Groups

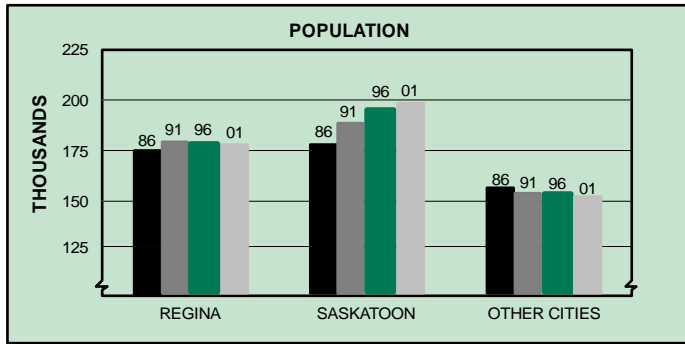

Table 5: City Population, Saskatchewan

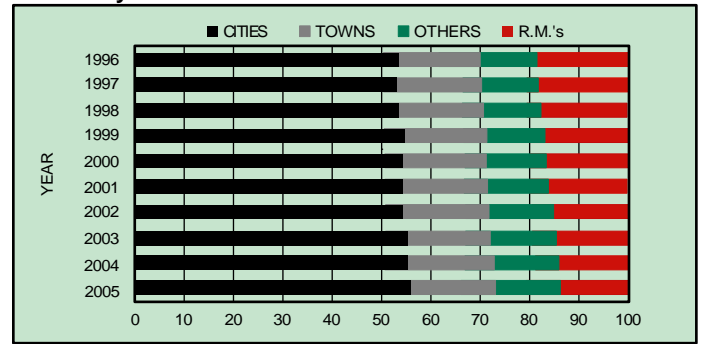

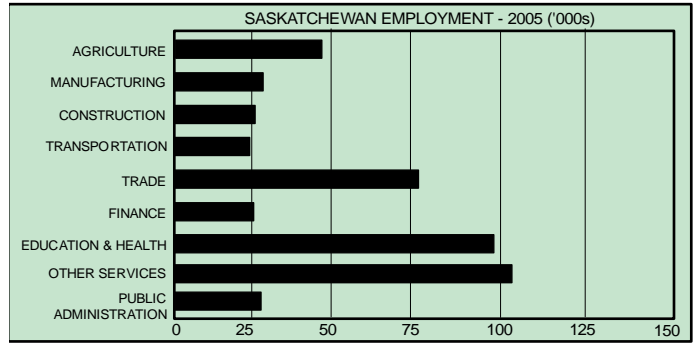

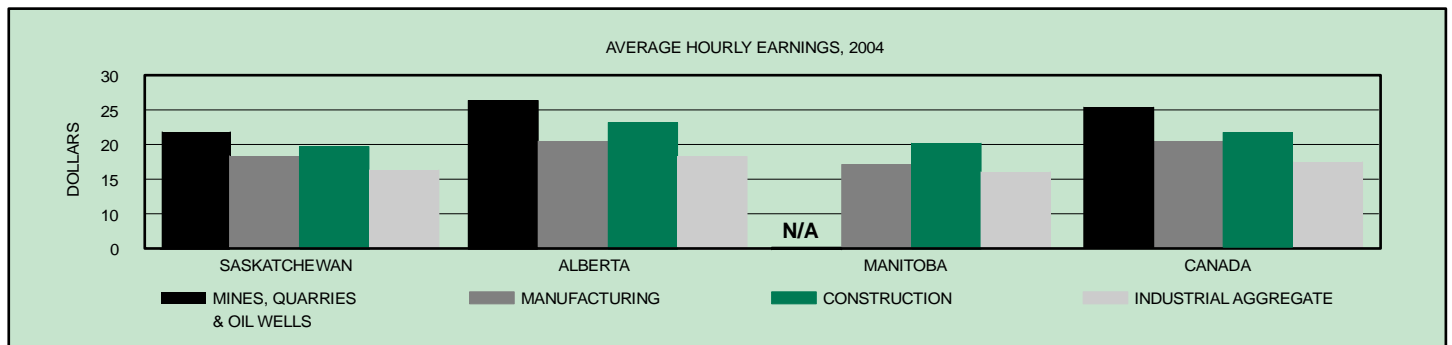

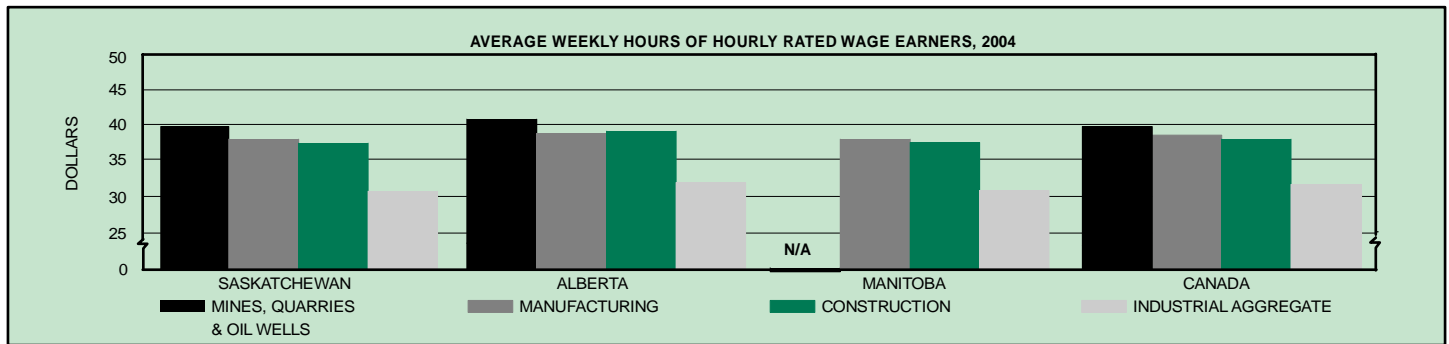

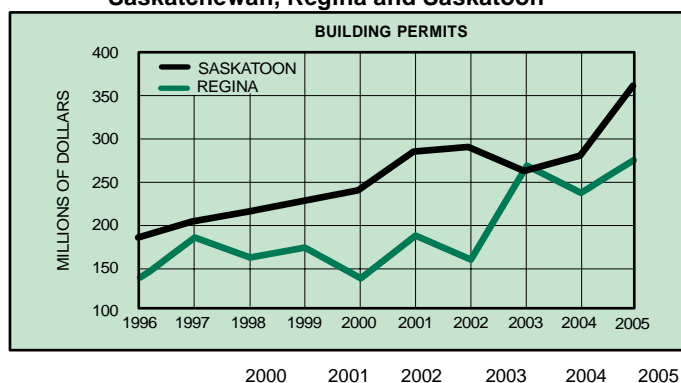

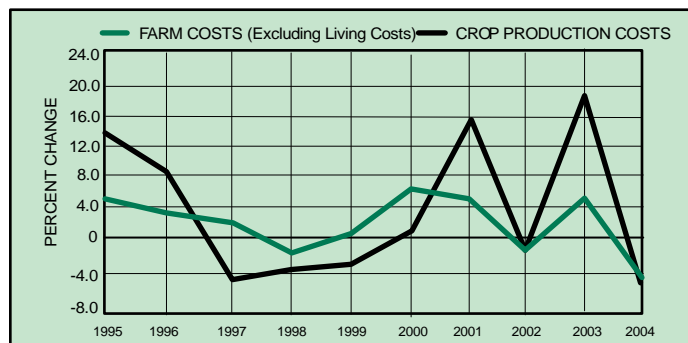

Table 19: Indexes of Farm Costs (1992=100)



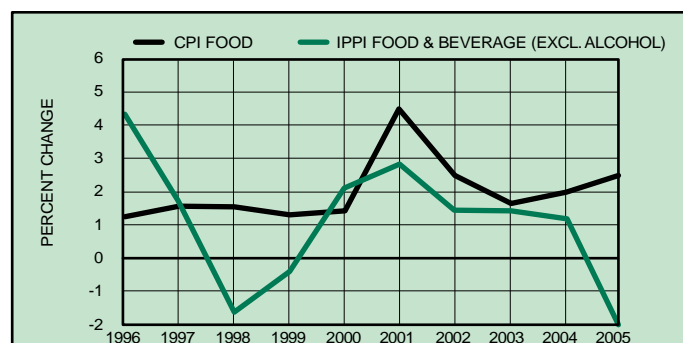

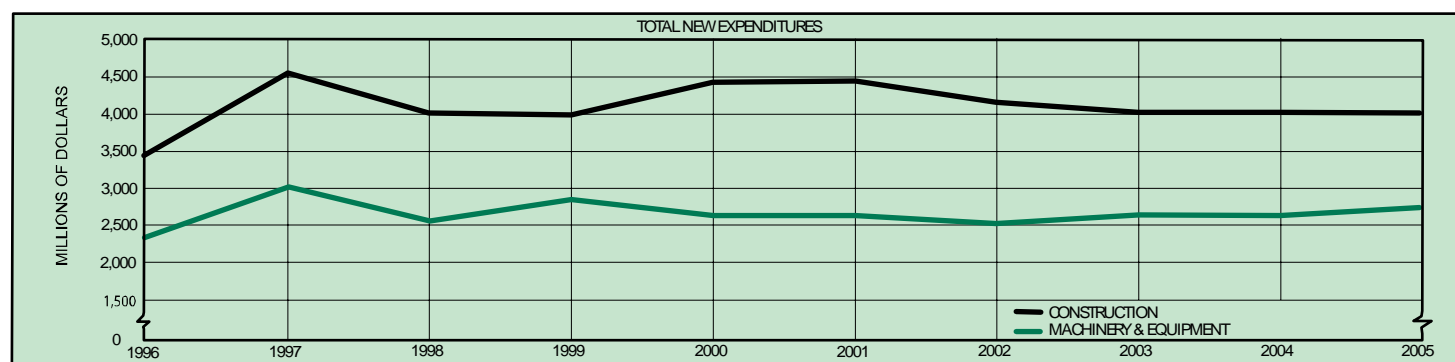

Table 21: Private and Public Investment by Industry, Saskatchewan



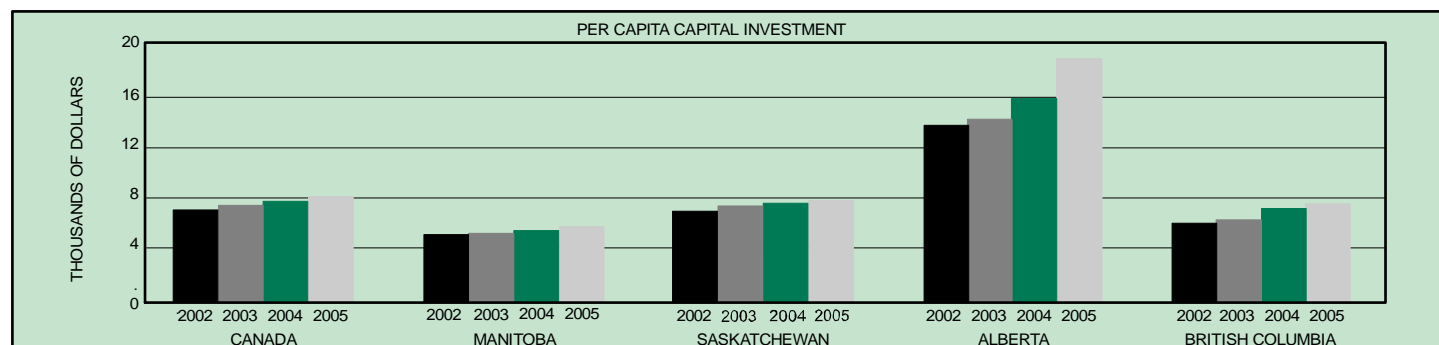

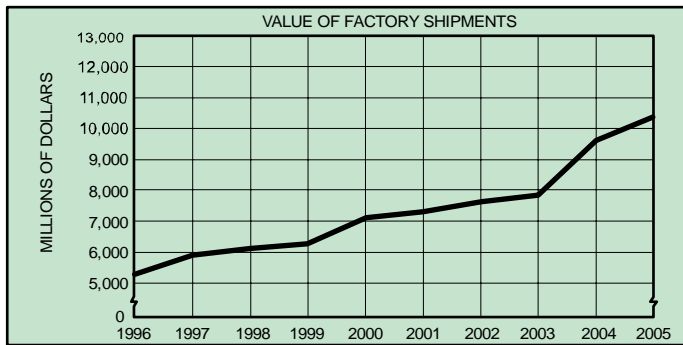

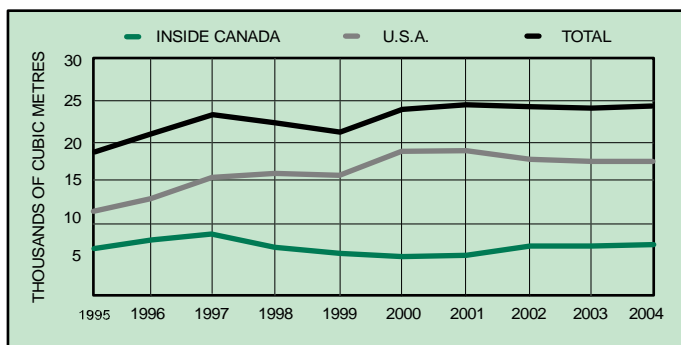

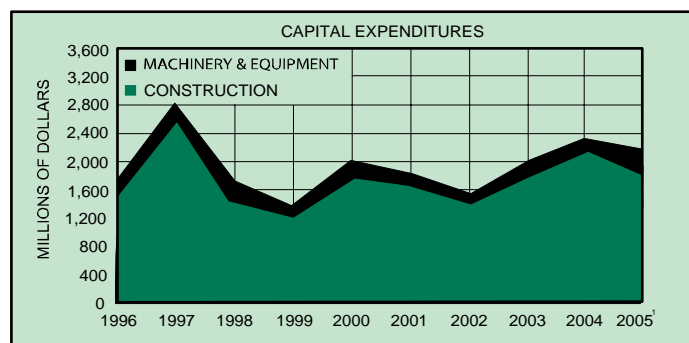

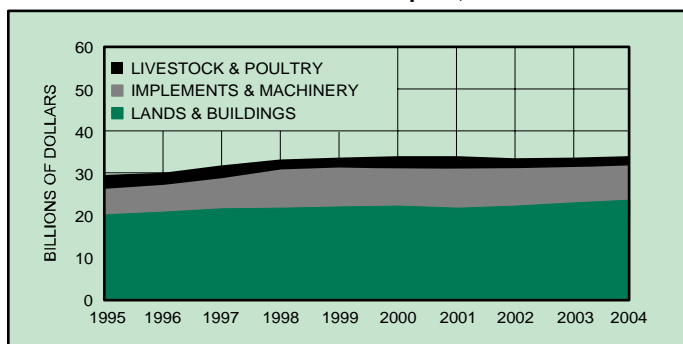

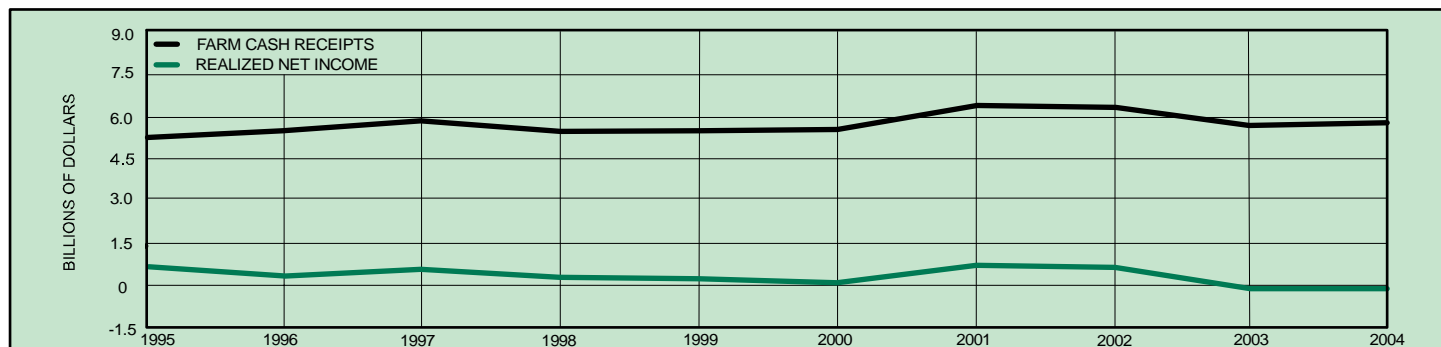

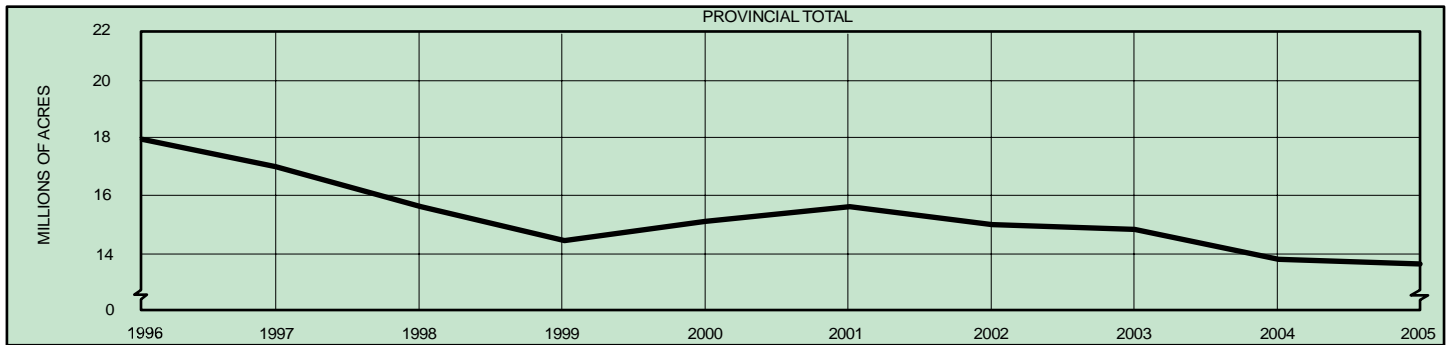

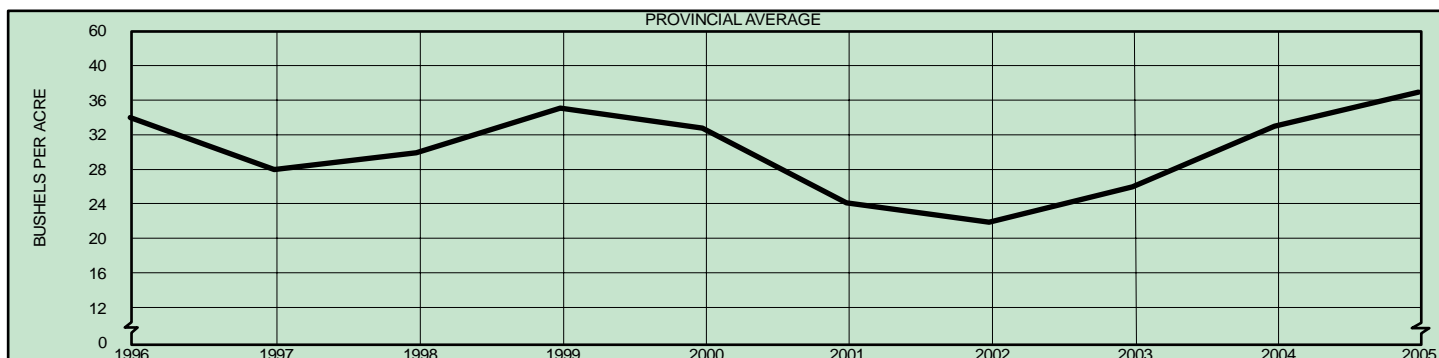

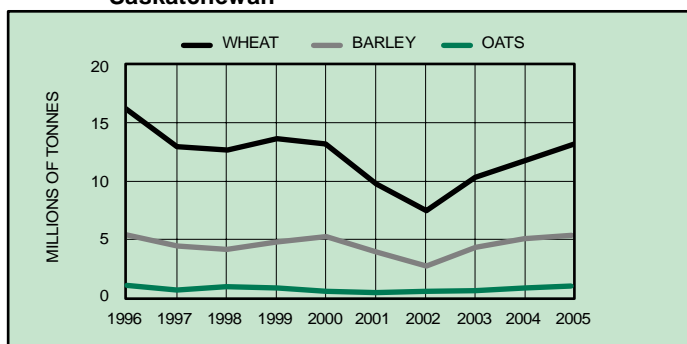

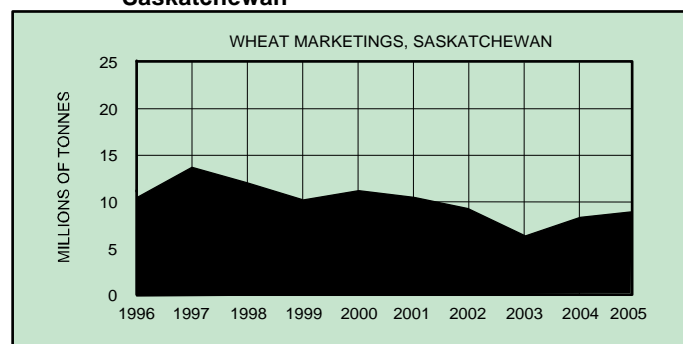

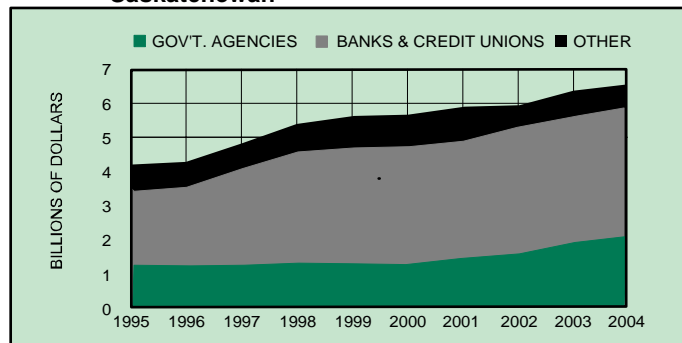

Table 43: Outstanding Farm Debt as of December 31, Saskatchewan

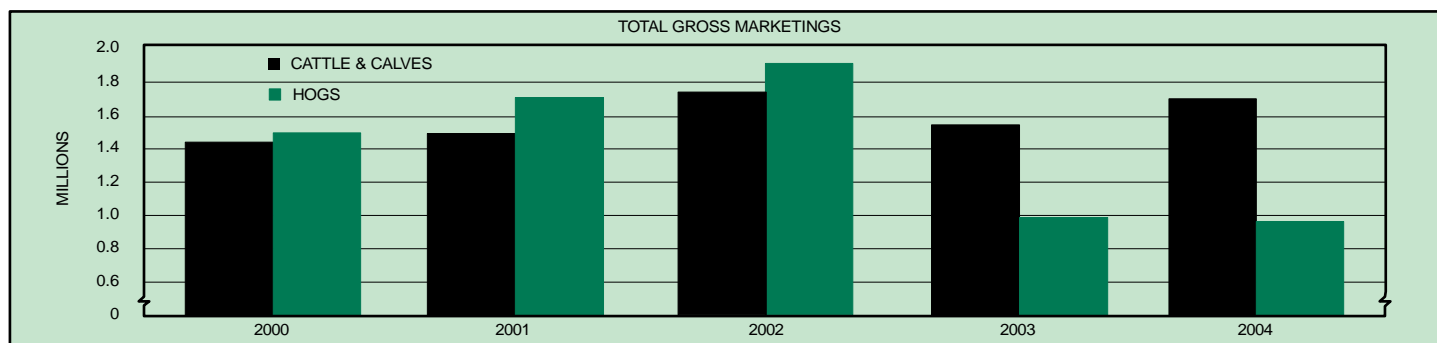

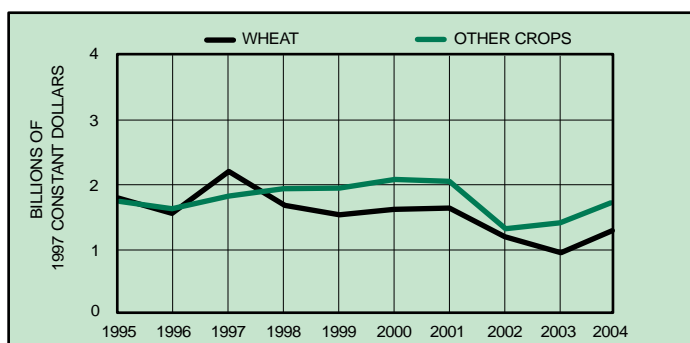

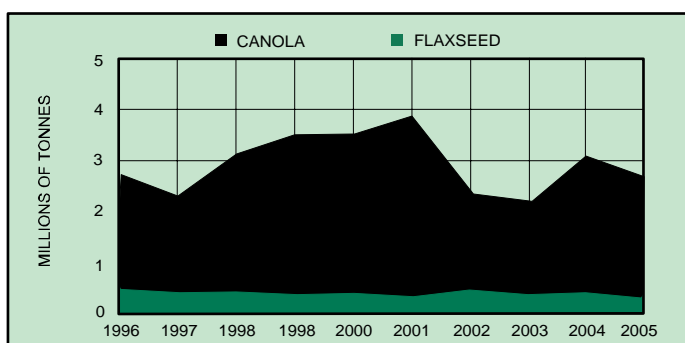

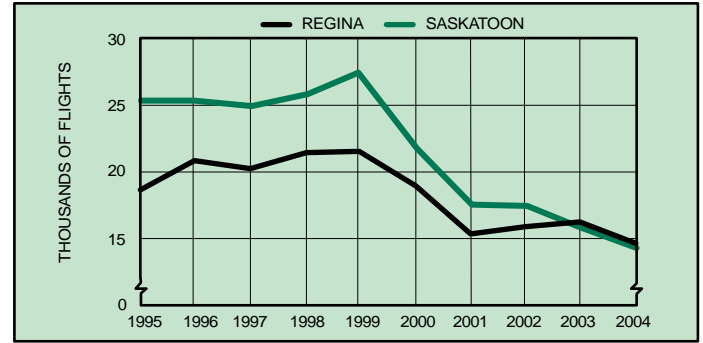

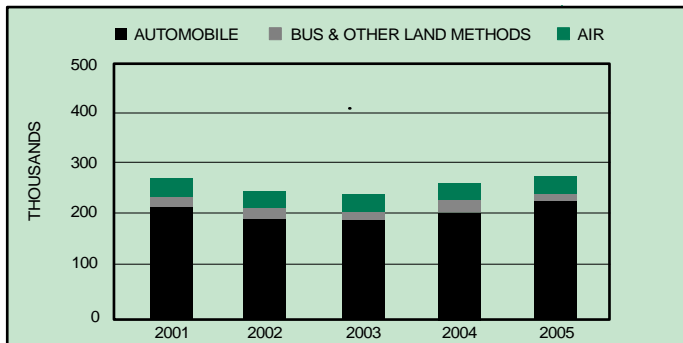

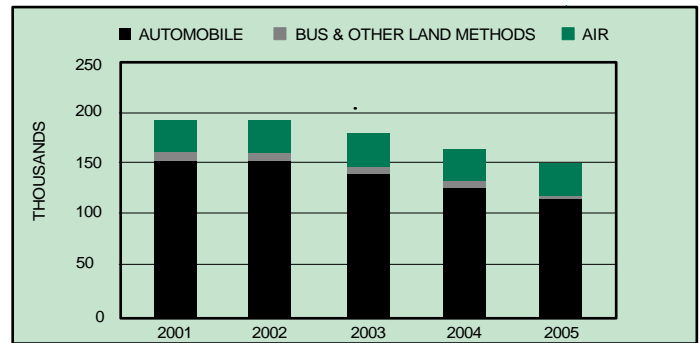

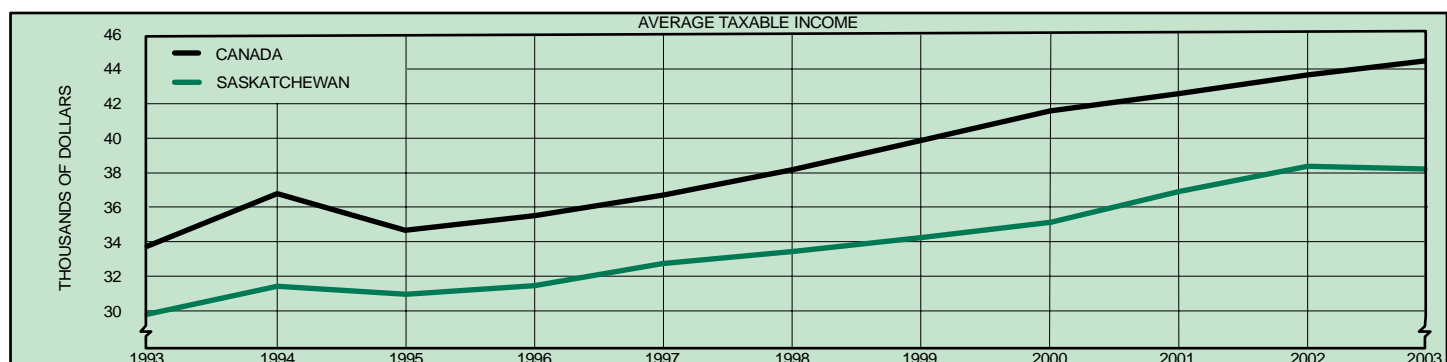

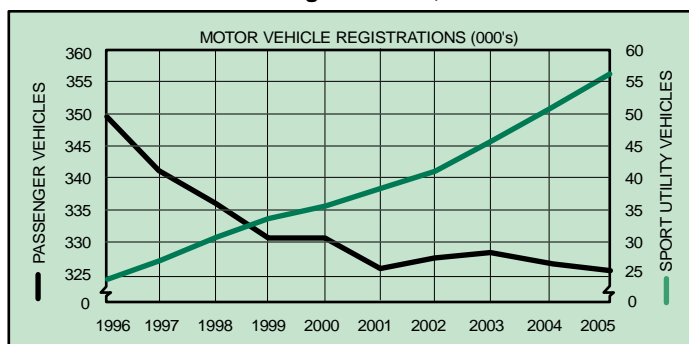

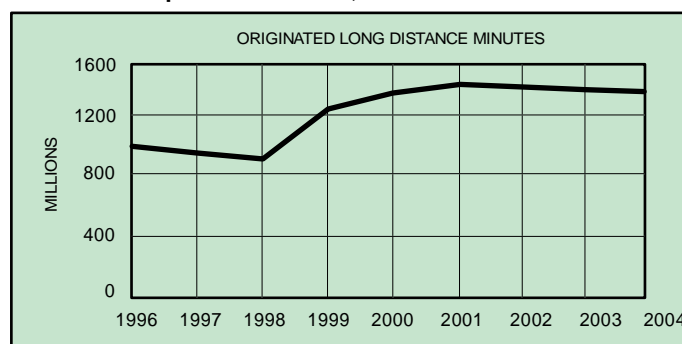

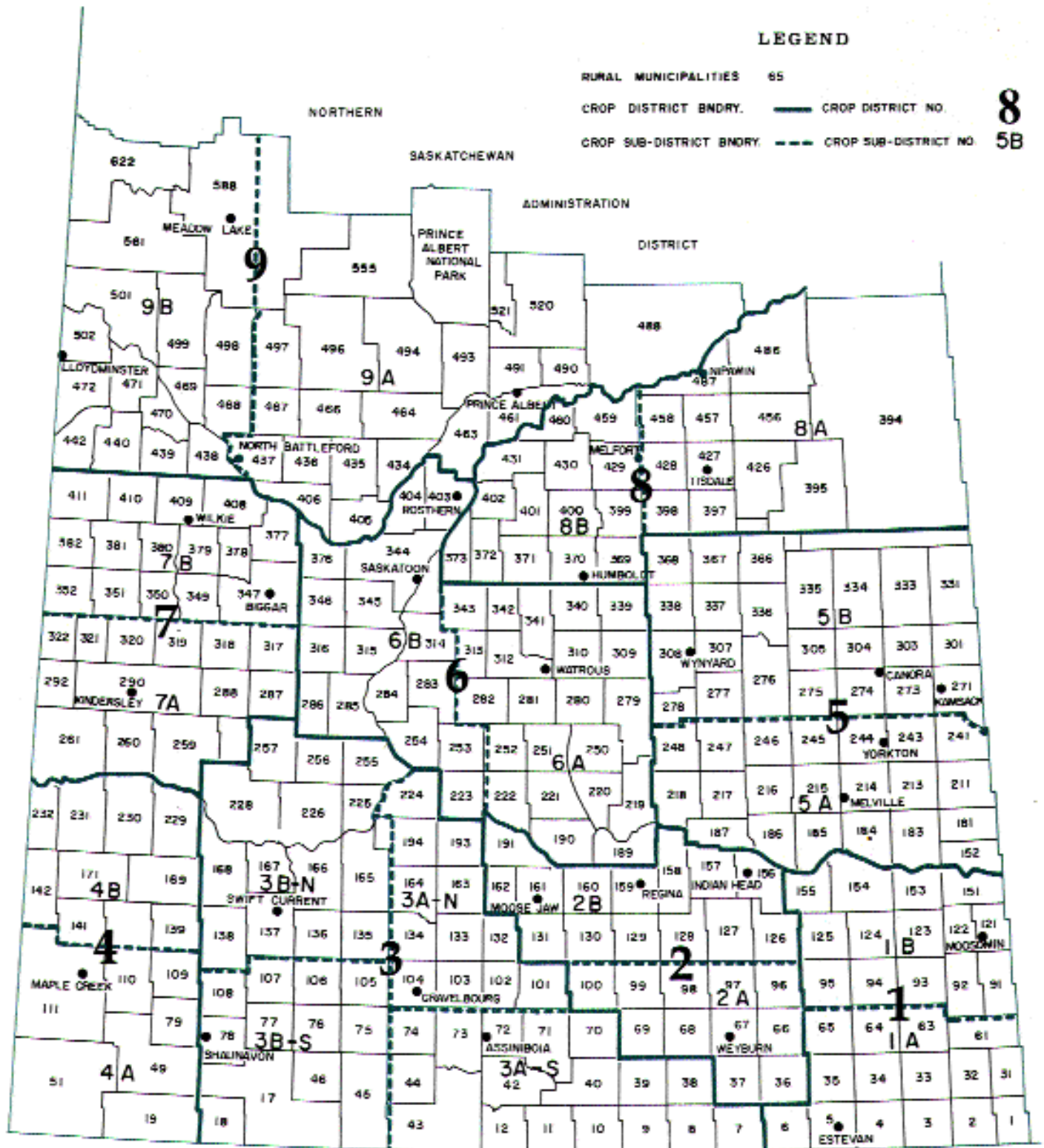

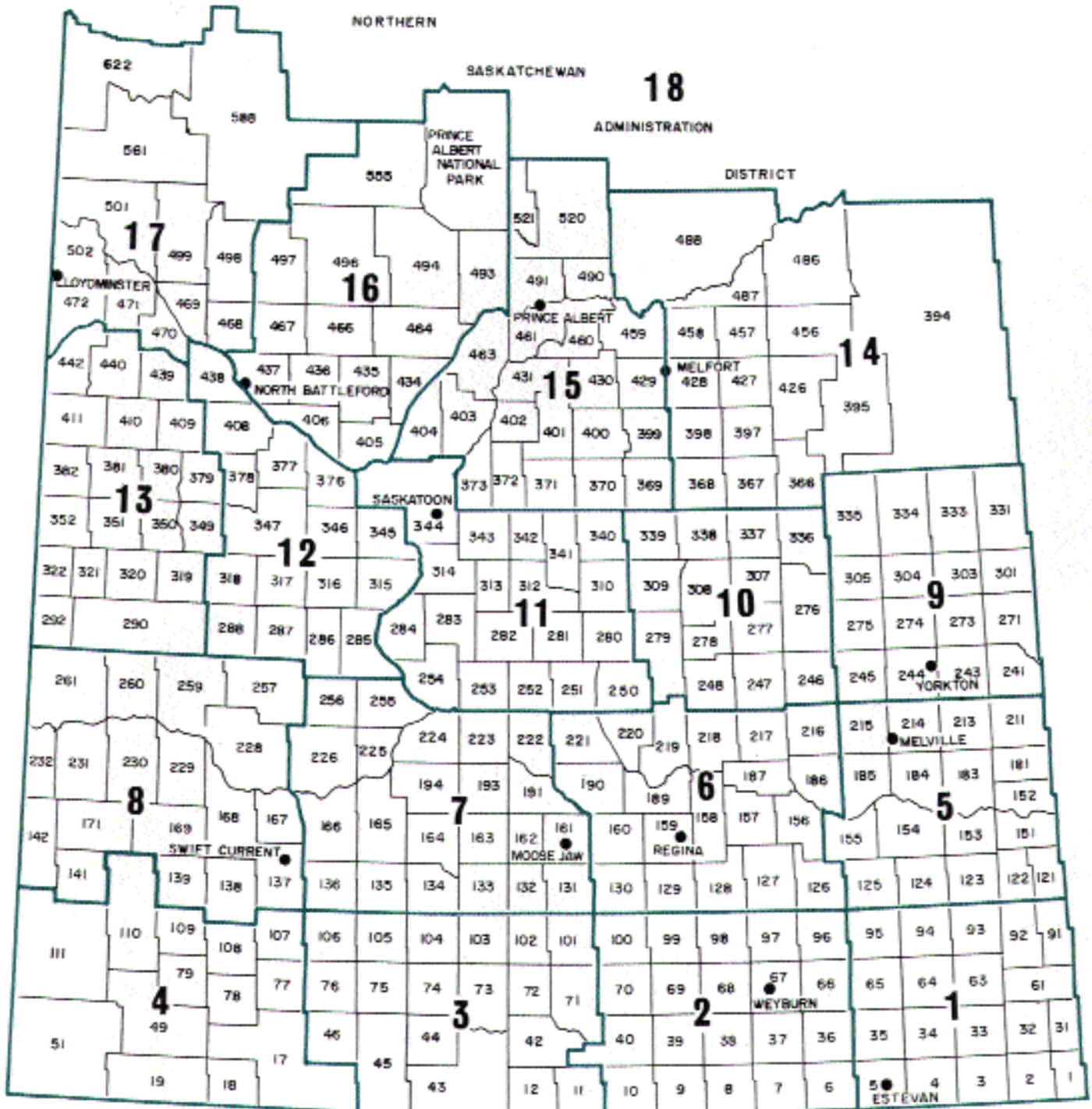

Saskatchewan Economic Accounts

The Saskatchewan Bureau of Statistics has developed a set of economic accounts which can be used to trace the development and growth of the Saskatchewan economy.

The purpose of the accounts is to measure the value of economic activity in each sector of the economy. This is done by means of a balancing set of accounts similar to the annual income and expenditure statements of a commercial enterprise.

The accounts have many useful functions. They consolidate information which is now provided through a number of scattered sources and organize it into a central framework. This allows many kinds of economic analysis to be performed ranging from monitoring current economic performance to analysis of structural change in the economy.

The Saskatchewan Bureau of Statistics has adopted the Chain Fisher volume index methodology for calculating real Gross Domestic Product (GDP). This method of calculating real growth in the economy removes potential substitution bias that exists when using a constant-dollar method (the Laspeyres index).

The Saskatchewan Bureau of Statistics has available, upon request, many more detailed tables and other information concerning the Saskatchewan Economic Accounts.

Saskatchewan Economic Accounts

Saskatchewan Gross Domestic Product (GDP) measures the total value of goods and services produced annually in the province. By removing the effects of inflation, it is possible to measure the volume of output. After adjusting for price changes, Saskatchewan's real Gross Domestic Product increased by 3.9 per cent in 2004 (chained 1997 prices).

In nominal terms, Saskatchewan's GDP increased by 9.2 per cent in 2004 to \$40,077 million. Personal expenditure on consumer goods and services rose by 3.4 per cent. Spending rose by 0.7 per cent on durable goods, 3.5 per cent on non-durable goods and 3.8 per cent on services. Government current expenditure on goods and services rose by 5.1 per cent in 2004. Total investment increased by 4.0 per cent in 2004.

In 2004, nominal exports increased 10.5 per cent from 2003 levels. Nominal imports increased by 3.1 per cent in 2003. In real terms, exports increased by 1.8 per cent while imports increased by 5.0 per cent in 2004.

Personal income in Saskatchewan rose by 6.3 per cent in 2004. Wages, salaries and supplementary incomes (on a Gross National Product basis) rose 4.2 per cent and net income of non-farm unincorporated businesses increased

by 3.5 per cent, and net income received by farm operators advanced by over \$600 million. After subtracting direct taxes, contributions to social insurance plans, and pension plan contributions, personal disposable income rose by 6.1 per cent. However, personal savings remained negative in 2004 (-\$275 million).

Real personal expenditure on consumer goods and services increased by 1.8 per cent, government expenditures on goods and services increased by 2.1 per cent and real gross fixed capital formation increased by 2.6 per cent. Final domestic demand for goods and services by individuals, the government and for investment purposes increased by 2.0 per cent in 2004.

This document represents an update to the Saskatchewan economic accounts, released in June 2005. Periodic revisions are common to all economic series, as more comprehensive data is obtained, in order to improve the accuracy, reliability and consistency of the data.
